CPNP COMPANY REGISTRATION AND COSMETIC PRODUCTS NOTIFICATION

According to Regulation 1223/2009, the placing of a cosmetic products on the market must be preceded by the registration of a manufacturer, supplier or distributor in the Centralized System for Notification of Cosmetic Products in the European Union. Each individual cosmetic product must be notified.

In order for a cosmetic product to be distributed throughout the EU, the same must own a Product information file (PIF) and Product safety report. The information file and the Safety Report which is part of it should contain certain details set out in Regulation 1223/2009.

The safety report according to Regulation 1223/2009 should be prepared by a professionally qualified person in the field of pharmacy, toxicology, medicine or other similar discipline.

- I. If you are a **producer or importer** of a product, which is going to be distributed in the EU, it is necessary to provide the following information:
- 1. Information regarding your company: name, address, contact person, phone number, email;
- 2. Cosmetic product's category and type, also its accurate name;
- 3. In cases of import, the country of origin;

The Member State in which the cosmetic product is going to be placed on the market

- 4. Nanomaterials and:
 - o Their identifying and chemical name, according to IUPAC
 - Their reasonably foreseeable conditions of use;
- 5. Presence of substances classified as carcinogenic, mutagenic or toxic to reproduction (CMR);
- 6. Framework formulation that allow rapid and appropriate medical treatment in case of problems occurring;
- 7. Original label and photo/photos of the original packaging; Original means corresponding to the one in first placing on the EU market.

The listed information is being uploaded in CPNP, so that it becomes accessible to toxicological centers and national competent organs.

- II. If you are a <u>distributor</u>, who will supply and trade a certain cosmetic product in a Member State, that has already been placed on the market in another Member State and you are translating an element of the label of the product on your own initiative in order to comply with national law, you should provide the following information:
- 1. Information regarding your company: name, address, contact person, phone number, email;
- 2. Product's category, its exact name in the Member State from which it is dispatched and its exact name in the Member State in which it is going to be provided, allowing its specific identification
- 3. The Member State in which the product is going to be distributed;
- 4. The name and address of the responsible person where the product information file is made available;
- 5. CPNP notification number (in any case the responsible person who is the producer of the product should have already done the initial notification)

The pricing of the service depends on the fact weather the producs are onecomponent or if they are multi-component

One-component product: a product consisted of only one element (for example a bottle of shampoo) **Multi-component products:** are for example sets of hair dying product, sets of make-up products and such ones, which are not sold separately.
